### **Vaccine requirements:**

In order to protect the health of your pet, All Bay Animal Hospital requires documentation showing that all boarding dogs have current Rabies, DHPP (Distemper), and Bordetella (Kennel Cough) vaccines. All boarding cats are required to have a current FVRCP vaccine. If your pet's vaccinations are past due, they will be given the required vaccines during his/her stay with us. The vaccination fee(s) will be added to your boarding charges. Dogs under the age of 4 months, and cats under the age of 3 months, have not completed their vaccination series and are considered to be unprotected from contagious diseases. If you choose to board your young pet that hasn't completed his/her vaccination series, then you understand and accept the risks of possible exposure.

I certify that I am the owner or authorized agent of the pet's listed above, and do hereby consent and authorize ALL BAY ANIMAL HOSPITAL and the staff to board my pet and to administer any vaccinations, medication, test, surgical procedure, anesthetic, or treatment that the doctor deems necessary for the health and safety of the above animal(s) while under their care and supervision. I understand that my pet(s) will receive an examination and flea inspection, and if fleas are found to be present on my pet, then a flea treatment will be administered at my expense. If my pet(s) should injure him/herself in an escape attempt, refuse food, become ill, or die while he/she is being boarded, I will not hold All Bay Animal Hospital or its staff responsible and/or liable.

I also realize that I am responsible for payment of the above procedures and treatments in full at the time that my pet(s) is discharged. If I neglect to pick up my pet(s) within ten days after he/she was due to be picked up, I understand that he/she will be deemed abandoned. If deemed abandoned, All Bay Animal Hospital is authorized to surrender the animal to the local animal shelter. Abandonment does not release me from my obligations to pay all boarding fees. I further agree that if I fail to pay, a finance charge of 1.5% per month (18% annually) will be added to my balance due and a collection agency will take over my account in attempt to collect a debt. If this occurs, I agree to pay all collection fees and/or attorney fees.

### **Emergency Care/Treatments:**

If my pet(s) becomes ill while in the care of All Bay Animal Hospital, I authorize all medical/surgical treatment that the doctor deems necessary. I understand that additional fees will be associated in this event. I acknowledge that in the event of my pet's illness, All Bay Animal Hospital will attempt to call and email me prior to administering any treatment. If they are unable to contact me immediately and my pet is critically ill, I authorize initial treatment to stabilize my pet until I or my pet's authorized representative can be reached. I agree to pay related expenses for my pet's treatment until I am available to discuss further care and associated fees with the attending veterinarian.

I represent that I am the legal owner or authorized representative for my pet(s) listed above. I certify that to the best of my knowledge, my pet(s) has not been exposed to contagious diseases within the last 10 days.
